General Terms & Conditions of The BID Enquiry

1. Please go through the instruction contained in this document carefully for bidding instructions.
2. For clarifications if any, please mail to storenpurchase@nitrr.ac.in (For Commercial queries) & pdewangan.min@nitrr.ac.in (For Technical Queries)
3. The bid should remain valid for a period of **150 days** from the date of opening. In case your offer has a different validity period that should be clearly mentioned in the quotation. Validity period may also be extended without change in bid prices, if required on mutually agreed basis only.
4. **The price of the goods quoted should be FOR NIT RAIPUR** inclusive of all applicable taxes(GST etc), service support, packing ,forwarding, insurance and other local services required for delivering the products at NIT Raipur.
5. Submission of bids: Bidders have to submit their bid through E-tendering mode only at website <http://www.tenderwizard.com/NITR>
6. Financial Bid (Microsoft Excel File) is to be downloaded from website www.tenderwizard.com/NITR and then is to be filled, saved and uploaded (through digital signature) on the same website and not to be submitted in hard copy at all.
7. Custom duty: The NIT Raipur have registration in Department of Scientific & Industrial Research (DSIR).
8. Bid Security (BS)/(Earnest Money, EMD) The Bidder/Tenderer shall furnish, as part of its bid, a bid security (BS) of INR 18,000/- only. The bid security shall be in Indian Rupees. The bid security should be submitted only through online payment gateway in e-tendering portal i.e. <http://www.tenderwizard.com/NITR>.
9. The firms registered with DGS&D & NSIC, if any, are exempted from payment of EMD provided such registration includes the item they are offering which are manufactured by them and not for selling products manufactured by other companies.
10. Any bid without EMD or bid not secured in accordance with above will be rejected by the Institute as non- responsive.
11. The bidders should quote their offer/rates in clear terms without ambiguity **for a period of one year service**. The services can be extended further on mutual consent at the same rate.
12. The rates should be quoted both in figures and words. In case of any discrepancy between the rates in figures and that in words, the rate in words will be accepted as correct.
13. Each bidder shall submit only one bid. A bidder, who submits more than one bid, shall be disqualified and considered non-responsive
14. The bidder has to sign and upload the acceptance of tender terms as per Annexure-I compulsorily.
15. The Bidder/Tenderer shall indicate unit prices in the prescribed format only.
16. The bid security of unsuccessful Bidder/Tenderer will be discharged /returned as promptly as possible but not later than 30 days after the expiration of the period of bid validity or placement of order whichever is later
17. The successful Bidder/Tenderer's bid security will be discharged normally with in 30 days after the completion supply order.
18. The complete Tender document can be viewed and downloaded only from the Website (www.tenderwizard.com/NITR) & <http://www.nitrr.ac.in/> during the tender sale period. The intending bidders should submit the tender documents sale price & tender processing fee, through e-payment, at the time of making online request.
19. **To participate in the E-tender, it is mandatory for the bidders to have user ID & password, which has to be obtained by submitting an annual registration charges of Rs. 2000/- +GST @ 18% to ITI, through e-payment. Also it is mandatory for all bidders to have class 3 digital signature certificates from any of the CCA (Controller of Certifying**

20. Incomplete tenders shall be liable for rejection without seeking any further clarification. We also reserve the right to reject any or all tenders without assigning any reasons whatsoever.
21. **Delivery/Execution period:** Delivery should be made according to time schedule which will be intimated at the time of placement of the work order. The maximum delivery period is 5 weeks from the date of signing of contract agreement mutually .
22. **Delayed delivery/ Execution:** In case of delayed delivery of the goods a penalty **0.5% per week or part of thereof subject to maximum of 10% will be recovered from the firm of the value of undelivered goods. Request for extension in delivery period should be made before the last date of supply as mentioned in Purchase Order**
23. **Non delivery beyond extended period:** If the bidder fails to execute the order within the delivery period as mentioned in the order, the order will be cancelled and EMD will be forfeited by the institute. Scope of Work

The scope of work of the bidder shall include the following:

1. Setup of infrastructure on Azure as per the cloud services mentioned in the tender document and to support Infrastructure during and after migration of Application. Providing Support to Application Vendor (Mastersoft Nagpur) during migration phase for Azure Infrastructure services deployed. The basic functionalities is shown in the Table 2.
2. For supporting cloud Infrastructure & portals initially for one year period and extendable further on satisfactory service support and performance.
3. Technical problems reported by the users should be responded within 2 hours and resolved within same day preferably. The bidder should maintain the ticketing windows for response time and resolution time.
4. While ERP Application support will be taken care by Application Vendor, bidder needs to provide Cloud infrastructure support during critical ERP application updates, planned maintenance of Application or unplanned outages during the contract period.
5. All the services to be delivered as per timelines mutually defined and agreed by NIT Raipur, ERP (Master soft) and Cloud Service Provider. The timeline schedule for related activities will be communicated to successful bidder after the issue of purchase order.
6. ERP of NIT Raipur is presently managed, maintained and supported by M/S Mastersoft ERP Solutions, Nagpur, Maharashtra. The successful bidder is required to provide necessary technical services and support as per their requirements for successful hosting and in day to day transaction of data on cloud services. In case of unsatisfactory support, the contract may be terminated with a prior notice of one month.
7. The selected bidder has to perform the DR drill once in a year two days.
8. The bidder should maintain Virtual Machines for Data Server, Virtual Machines for App server, Storage Accounts, Load Balancer, Azure DNS, Premium SSD Managed Disks, Data Transfers, IP Addresses, VPN Gateway and Application firewall in Central India, Azure Site Recovery in south India region and Traffic Manager in East US preferably.

9. The bidder is required to send onsite support engineer for resolution of technical issues to the Institute as and when required by NIT Raipur (If the issue is not resolved remotely on time frame).
10. For remote support, the bidder shall provide a helpline number (and email) which successful bidder must ensure support (24 x 7 x 365 days) for any issue related to availability and accessibility of Service Provider system.
